NEBAALAS OFFICERS

- i. **THE VICE-PRESIDENT is a Three (3) year commitment**, and shall be elected and serve for a one-year term as the Vice President, then automatically become President at the termination of the predecessor's term of office. The term shall encompass the completion of the Annual Awards event to the completion of the Annual Awards event the following year.
- ii. **THE VICE-PRESIDENT ELECT is a four (4) year commitment**, and shall be elected and serve for a one-year term as the Vice President- Elect, then automatically become Vice-President at the termination of the predecessor's term of office. The term shall encompass the completion of the Annual Awards event to the completion of the Annual Awards event the following year.
- iii. **THE SECRETARY** shall be elected and serve a minimum two-year term and shall be eligible for consecutive re-election. The term shall encompass the completion of the Annual Awards event to the completion of the Annual Awards event for **two (2) consecutive years**.
- iv. **THE TREASURER** shall be elected and serve a minimum two-year term and shall be eligible for consecutive re-election. The term shall encompass the completion of the Annual Awards event to the completion of the Annual Awards event for **two (2) consecutive years**.
